1. Rationale and Philosophy

The Accredited Hand Therapist (AHT) Award is given in recognition of an individual therapist's experience, knowledge, skill, and their personal contribution to the specialism. It provides a goal for therapists completing BAHT accredited courses by achieving points towards accreditation.

2. Application Process

- 2.1 The applicant must be a member of BAHT and fulfil all the application criteria before submitting their application.
- 2.2 The completed Application Form must be submitted electronically AND the original hard copy sent by post to the BAHT AHT co-ordinator.
The contact details for the AHT co-ordinator are available on the BAHT website or from the BAHT Secretary.
- 2.3 **Electronic Applications.**
Where practicable, the application should be made electronically with only the required original documents (testimonies and clinical hours log) plus one original signed application form and CV sent by post to the AHT co-ordinator. Supporting evidence needs to be scanned and organised in such a way that makes it possible to be sent and read easily. Further guidance on this is given at the end of this document. **Applications should be received by the AHT co-ordinator no less than two weeks prior to the next Education Sub Committee meeting date. Meeting dates are publicised on the BAHT website or can be obtained from the BAHT Secretary.**
- 2.4 **Assessment**
Applications are assessed by the AHT coordinator plus two members of the BAHT education sub- committee, then discussed at the education sub-committee meeting.
- 2.5 Following the meeting, the AHT co-ordinator will contact the applicant with the outcome, this is usually done by email with attached confirmation letter.
- 2.6 AHT awards are presented at the annual BAHT conference. If the applicant is unable to attend conference their certificate and badge can be sent by post.

3 Criteria for AHT Award

- Applicants must be a member of BAHT.
- Applicants must have accumulated 12 BAHT points.
- Applicants should be actively working clinically in Hand Therapy.*
- 4000 clinical hours in hand therapy must be demonstrated in the clinical log.
- 3 Guided testimonials must be provided - see below.
- Able to demonstrate (within an extended CV an or attached application form)
 - Promotion of the specialism.
 - Clinical expertise at an advanced level.
 - Evidence of continuing learning and development.
 - Management and leadership skills within the specialism.
 - A personal contribution to Hand Therapy.

Applications should not be made until all 12 points have been accumulated, and the above criteria is satisfied. The last piece of work should have been completed no more than two years prior to submission of the application.

- In the event that the most recent BAHT points were awarded outside of the 2-year requested timeframe, an additional piece of supporting work should be provided. This should take the form of a 500-word reflective synopsis of how your study has influenced your role and enhanced your learning and development as a hand therapist since its completion.

4 Log of Clinical Hours

- 4.1 The application should be supported by a log of clinical hours spent in Hand Therapy. A minimum of 4,000 hours (i.e. the equivalent of two and a half years' full-time) clinical work is required. This log should be signed by an appropriate supervisor. See appendix C
- 4.2 **Overseas Applicants**
The AHT award is based on a working knowledge of hand therapy practice in the United Kingdom. To ensure parity, overseas applicants with less than 50% of their clinical experience gained in the United Kingdom will be awarded an associate accreditation which will be known as Associate AHT (BAHT) and will recognise where they have completed the majority of their clinical hours.

5. Testimonies

- 5.1 3 written testimonies should be provided. Each testimony should take the form of a short statement provided by someone who is able to judge the worth and quality of the applicant's work, experience and expertise. This may be illustrated by reference to observation of particular incidents.
- 5.2 Each testimony must provide the name, position, title and contact details of the person who has compiled the testimony and be signed and dated by that person.
- 5.3 Each testimony should reflect a different aspect of the candidate's skills and knowledge pertinent to hand therapy. At least one testimony should be from a colleague, one from a line manager and one from a consultant hand surgeon who has worked with the candidate within the last two years.

6. Extenuating Circumstances

The Education Sub Committee will consider extenuating circumstances such as maternity leave and provide individual guidance as needed. Queries should be sent to the BAHT secretary in the first instance.

Actively practicing means “drawing on your professional skills/knowledge in the course of your work” and it is a personal decision as to whether your work fulfils this. This is in line with guidance from the Health Professions Council. The Education Sub Committee will consider extenuating circumstances such as maternity leave and provide individual guidance as needed.

This evidence is required when submitting an application to the Education Sub-committee of BAHT for various routes to attaining Accredited Hand Therapist status e.g. Accreditation of Prior Learning. It can also be used to demonstrate the area/s in which you work / have worked for re-accreditation.

Please complete each entry with the required information. It is imperative that you obtain the signature of your line manager or in the case of Private Practice a Consultant for whom you work.

It is your personal record and so it is in your interest to keep it safe and to make entries as and when necessary. It is only necessary to enter the end date when moving from one clinical area to another or when changing employer / Directorate.

- Course Certificates (including evidence of courses being used to claim BAHT points)
- Evidence to support Promotion of Specialism
- Evidence to support Management Skills
- Evidence to support Personal Contribution to Development of Hand Therapy
