The call for abstracts for the 2017 BAHT conference is now open!

Abstracts are welcome on any hand and upper-limb related theme. The deadline for submission is Monday 24th July.

Abstracts must be plain text only (no tables, references or colours) and a maximum of 300 words excluding the title. Please indicate whether you would prefer to present your abstract as a free paper (oral presentation) or poster.

Please structure your abstract as follows:

- Title
- Objectives: 1-2 sentences that clearly indicate the main study question(s) and its clinical importance
- Methods: Sufficient information to understand the experimental design and the analytical techniques used
- Results: Objective data in answer to the study question(s)
- Conclusions: Conclusions that are directly supported by the study results and their implications for clinical practice. Avoid overgeneralisation
